Guidelines for making an appointment for registration at The Hague International Centre



To ensure an efficient workflow we have set up a few guidelines for your reference.

Making an appointment for registration.

From 23 October 2018 appointments for registration can only be made through the appointment tool at our website: www.thehagueinternationalcentre.nl.

Appointment tool

- Employers, intermediaries/relocator, or internationals can book an appointment for municipal registration. Registration can be combined with providing biometrics and/or collecting a residence permit from the IND. A combined appointment can only be requested once the application for a residence permit has been processed or a v-number is known.
- The calendar will suggest the next available time slot depending on the use of IND services and the size of the family.
- Appointments have to be confirmed by The Hague International Centre. We will confirm appointments within 2 working days. A separate confirmation email will be sent automatically.
- Appointments can therefore only be made 2 working days from today.
- Appointments can only be made 3 months in advance.

Contact person

- We ask for a primary contact person for the appointment. This can be the employer, relocator or employee. Confirmation emails will be sent to the email address of this primary contact person.
- We do require a name and contact person of the employer. The employer is recognised as sponsor of the IND, not the intermediary or relocator. The employer is responsible for the relocation of the international. To monitor the facilities for internationals in The Hague region we are in the process of improving our account management with international employers.
- We will not contact the employer for appointments if the employer is not designated as the primary contact person.

Changing appointments

- The confirmation emails which the primary contact person will receive will contain a link to change or cancel the appointment. Please use this link to change the date or time of the appointment.
- After a change we need to confirm the appointment again. We will confirm the appointment within 2 working days. Therefore, an appointment can only be changed to a new date 2 working days from today.
- If you want to change details of the appointment other than the date and time (i.e. number of people, personal details), please cancel the appointment and make a new appointment online.

Eligibility

An employee, partner and/or child(ren) are eligible for an appointment for registration if they meet the following two requirements:


- The employee works for an international organisation, embassy, non-governmental organisation, knowledge institute or company which is a recognised sponsor of the IND or assisted by The Hague Business Agency or InnovationQuarter.
- The employee will be registered on an address in the municipality of The Hague, Delft, Rijswijk or Leidschendam-Voorburg.

Required documents

- Before making an appointment, we do not require copies of official documents or proof of the IND decision letter anymore.
- The employer, intermediary or international is responsible for filling in the correct details, selecting the right procedure and for bringing the required documents to the appointment. Filling in incorrect details may result in a cancellation of the appointment or a failure to register.
- We do require valid passports/ID, confirmation of legal stay and a proof of occupancy before we can complete the registration for the municipality. Please bring the necessary documents to the appointment or make sure the international brings them along.
- We do not require birth, marriage or divorce certificates for first registration at The Hague International Centre. It is possible to register with a passport/ID. We do strongly encourage families to hand in certificates. Please note, some other municipalities as regular registration desk of The Hague may require you to register certificates upon arrival.
- The required documents can be found on www.thehagueinternationalcentre.nl and in the confirmation emails sent to the primary contact person.

Required information

When requesting an appointment, the following information needs to be included in the appointment form for all persons. We will otherwise not be able to process the request for an appointment.



Registration on correspondence address of employer

- If an employee has not found a permanent house address upon arrival, The Hague International Centre offers the possibility to companies and organisations to temporarily register on the correspondence address of the employer.
- This service is, however, not possible for all companies and organisations.
- The employer has to be located within the municipality of The Hague, Delft, Rijswijk or Leidschendam-Voorburg.
- You cannot make an appointment for registration on a correspondence address which has not been pre-approved by The Hague International Centre.
- Please contact The Hague International Centre to find out whether you can make use of this service.

IND

The Hague International Centre and the Immigration and Naturalisation Service (IND) have a Dutch residency procedure for international staff. This is a combined appointment for municipal registration and collecting the residence permit (biometric information might be collected during the appointment). This procedure applies only if the employee is a(n): Highly Skilled Migrant; Intra Corporate Transferee; Scientific Researcher; NGO employee; Start-up employee; EU Blue Card holder; or an International Graduate (Orientation Year). They should also live or work in The Hague, Delft, Leidschendam-Voorburg and Rijswijk. The company may already submit an application for a residence permit before the applicant arrives in the Netherlands. The application forms can be found on the website of the IND. A combined appointment can only be requested if the application for a residence permit has been processed or a v-number is known.

It is also possible to collect the residency document from the IND at The Hague International Centre. A notification will be sent when the document is ready. Residency documents can be picked up without appointment from [redacted] from 09:00 to 12:00.

Handing in missing certificates (only for individuals registered at The Hague International Centre)

To hand in missing certificates, a follow-up appointment will have to be scheduled. This can be done by sending an email to [redacted]@denhaag.nl. In a follow-up appointment only the certificates of residents of The Hague municipality can be processed. Residents of Delft, Rijswijk or Leidschendam-Voorburg need to make an appointment in their own municipality.

Please be considerate of the following *best practices*:

- Please make sure all appointment requests include the required information.
- Please only make combined appointments once the application for a residence permit has started or a v-number is known.
- Please try to minimize the cancellation and rescheduling of appointments.
- Please make sure all necessary documents are brought to the appointment and all to be registered individuals are present.
- Please make sure appointments are attended on time.
- Please provide us feedback so we can work to continue improving our services.

Vanuit IQ Foreign Investments houden we ons uitsluitend bezig met de nieuwe investeringskansen die de Brexit voor de regio creëert. Onderwerpen als handel/import-export of vrij verkeer personen/Britse expats houden we zijdelings in de gaten.

Wel hebben we de banden met de huidige Britse investeerders in het afgelopen jaar aangehaald en staan we klaar ze te assisteren zodra de gevolgen van de Brexit bekend zijn. Dit met het oog op behoud of misschien wel uitbreiding van activiteiten in NL. De Britse overheid heeft inmiddels een toolkit gemaakt, zodat bedrijven zich alvast kunnen voorbereiden:

Voor wat betreft de EMA geldt dat de sector in de UK ook afwacht welke gevolgen de Brexit zal hebben op haar personeel, toegang tot (EU) kapitaal, regelgeving en handel in medicijnen, alvorens een keuze voor eventuele relocatie te maken. Wel draagt de komst van de EMA nu al bij aan het versterken van de internationale aantrekkelijkheid van NL (voor bijvoorbeeld Aziatische en Amerikaanse bedrijven).

Een ander gevolg van Brexit is dat in toenemende mate Britse bedrijven voor de zekerheid alvast een Europese entiteit opzetten, zodat ze na Brexit vanuit die Europese vestiging nog wel zaken binnen de EU kunnen doen. Een indirect gevolg van Brexit is dat de huidige onzekerheid ervoor zorgt dat vooral Aziatische bedrijven meer interesse in Europese landen op het vasteland hebben voor het opzetten van een Europese vestiging.

Dit zijn trends die we waarnemen, waar geen harde cijfers aan ten grondslag liggen en waarvan we niet direct kunnen zeggen wat de effecten ervan op Den Haag zullen zijn.

Vanuit THBA volg ik Brexit op de voet, woon Brexit events bij en maak notities van de laatste ontwikkelingen. Helaas is er nog geen concrete vooruitgang geboekt in de onderhandelingen.

Hieronder een samenvatting van mijn notities en in bijlage een mail van Brexitloket met nuttige informatie.

Brexit in het kort

- Cruciale datum Brexit is **29 Maart 2019**. Artikel 50 treedt in werking. (Article 50 is a plan for any country that wishes to exit the EU to do so).
- Gevolgd door **transitie periode** (*alleen bij Trade agreement deal*) van 21 maanden (t/m 31 dec 2020) waarin "free movement" is toegestaan. VK mag nieuwe trade deals aangaan buiten EU om en worden pas actief 1 januari 2021.
- Er wordt steeds meer rekening gehouden met No Deal (hard brexit)

Er zijn 4 Brexit scenarios

- Free Trade Agreement (soft)
- Chequers (Proposal of UK Prime Minister May) |
- Noorwegen model |
- No Deal (WTO voorwaarden treden in werking) (hard)

Tijdens een VK/EU Summit in Oktober 2018 is het uitgangspunt een "Deal" tussen EU & VK. Onderhandeld word over "af te rekenen bedrag", grens met Noord Ierland, status inwoners EUinVK en VKinEU en "Trade & import". = niet gelukt

Laatste status

- Grote diversiteit in parlement (Conservative - Labour),
- Grote diversiteit onder bevolking (laag - hoog)
- Grote diversiteit tussen regio's (North vs South)
- Bij "No Deal" wordt WTO Regels actief (Customs, Checks & Tariffs)
- Grote gevolgen voor Nederland (economisch, logistiek, personen verkeer)
- Oktober 2018 VK/EU Summit. Uitgangspunt is een "Deal" = Niet gelukt

- 17 October Minister [redacted] Blok of Foreign Affairs does not expect that the European Union and United Kingdom will reach a political agreement on the Brexit on Wednesday. "More time is needed to complete those negotiations successfully. At the same time the risk remains that it will not work", he said on Tuesday evening after a meeting of Foreign Ministers and EU-Brexit negotiator Michel Barnier, NOS reports.
- 21 October: 700.000 Call for Second referendum

- **13 December 2018:** EU summit. If deal not done by October, this is the fall back option if the two sides still want to reach agreement. - **29 March 2019:** As things stand, deal or no deal, Brexit is due to happen at 11pm UK time
- **31 December 2020:** If all goes to plan a transition period will then last until midnight on this date

Brexit gaat veel impact hebben op Britse burgers en bedrijven die zaken doen met de UK. Zo raakt het ook de Haagse burgers en economie. De Rijksoverheid, RVO, Douane, VNO-NCW, MKB Nederland besteden veel aandacht om bedrijven voor te bereiden op Brexit, ongeacht het scenario.

Het zal ook impact hebben op de gemeente als organisatie. Deal or No deal, harde of zachte Brexit. Ook Den Haag zal zich moeten voorbereiden. Via VNG, MinBZK en Europa Decentraal wordt er een impact scan ontwikkeld. Deze berust echter op input vanuit grote gemeenten.

- Brexit kan leiden tot nieuwe acquisitiemogelijkheden (denk aan EMA). The Hague Business en InnovationQuarter kijken naar kansen en bedreigingen voor buitenlandse investeringen.
- Naast kansen, zijn er ook bedreigingen voor de economische ontwikkeling.
 - Is het net zo makkelijk na Brexit om Britse kenniswerkers aan te trekken naar Den Haag?
 - Vrij verkeer van goederen zal beperkt worden. Voor import/export tussen UK en NL zal veel meer regelgeving gaan gelden. Welke sectoren hebben met name import/export banden met UK vanuit Den Haag? (grote impact verwacht op havens Rotterdam en Amsterdam, Schiphol)
 - Vrij verkeer van personen zal aan banden worden gelegd. Wat is de impact op grenswerkers (pendel Londen/Den Haag van bijv. Shell)? Wat is de impact op Rotterdam/The Hague airport?
 - Wat is de inschatting voor de Haagse economie?
